- No subletting of space is permitted without the consent of the WSNS Director, Linda Krause – email: LMK@wsma.org
- Exhibitors are responsible for shipping, storage, and installation of exhibit materials, and all costs involved thereby.
- There is a **\$100 service fee on all cancellations**. Cancellations received on or after September 2, 2022 will be charged a \$250 service fee.
No refunds for cancellations received after September 5, 2022.
- The WSNS and Element by Westin do not guarantee against theft, vandalism or otherwise.
- It is expressly understood that exhibitors shall indemnify and hold harmless the WSNS and the Element of all liability (damage or accident) that might ensue from negligence by the exhibitor in connection with transfer, installation, maintenance or removal of exhibits, or in display of exhibits.
